2. The Company operates in a single business segment of manufacture and sale of garments. As such, no further disclosures are required.



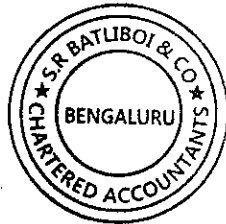
Limited Review Report

Review Report to The Board of Directors, Gokaldas Exports Limited

1. 
